## HOME-BASED AND OTHER EDUCATIONAL PROGRAMS (Participation in District Classes or Athletics/Activities)

#### Participation in Classes

Children residing in the District and who are receiving education through a home-based education program or a private school may request permission to enroll in classes offered by the School District.

To enroll in classes offered by the District, the child must complete the registration and enrollment forms provided by the District and provide the information set forth below. Students who wish to attend on a half-time basis (four periods or four hours of instruction) as part of their education program are required to take classes in literacy, mathematics, and science, at the grade level consistent with the age and ability of the student.

- A written request must be made for each class the child requests to attend to the School District's Assistant Superintendent of Curriculum and Assessment.
- The decision of whether or not to allow enrollment in specific classes is at the discretion of the Superintendent or his/her designee.
- Admission of home-based or private school students will be on an individual case-by-case basis for each student and each class.
- Approval for enrollment in one class requested by a home-based or private school student does not require the District to approve admission into any other classes.
- Course capacity and availability will be considered for admission into classes offered by the District.
- Home-based students and private school students enrolling in specific classes offered by a school must comply with the District's admissions processes, including proof of residence, proof of required immunizations/waiver, and other requirements for enrollment.
- Home-based students and private school students who are allowed to participate in classes offered by the District will be placed in the class that is age-appropriate and/or according to past education history as determined by the Superintendent or his/her designee.
- Home-based program students and private school students who

are allowed to attend classes offered by the District shall be subject to the same policies, rules, regulations, and course requirements as are applicable to all other students.

Requests to enroll in classes offered by the School District from children residing in the school district who are enrolled in a public school other than the District (i.e., a virtual school) will require a separate agreement between the District and the other public school (i.e., an agreement between the District and the virtual school).

#### Participation in Activities/Athletics

Children residing in the District who are not enrolled in the District (i.e. students in home-based education programs, private, or other public schools) (referred to in this subsection as "Resident Children") and who are not under suspension or expulsion by a Wyoming school district may request permission to participate in activities and athletic programs offered by the School District under the following guidelines.

- A written request for each activity or athletic program the child wishes to participate in must be made to the Superintendent or his/her designee.
- Resident children requesting to participate in activities at SHS or SJHS must comply with all rules and policies of the District and of the Wyoming High School Activities Association(WHSAA) with respect to the activity and pay any fees (such as catastrophic insurance fees) required by WHSAA.
- Resident children participating in activities or athletic programs offered by the District shall be subject to the same policies, rules, regulations and course requirements, and prerequisites as are applicable to all other students.
- Scholastic Eligibility: Resident children must submit grade reports weekly to the athletic director or his/her designee to demonstrate scholastic eligibility. If grade reports are not submitted or do not demonstrate eligibility the student is ineligible for participation.
- All other eligibility requirements will be considered as outlined in the Athletics and Activities Policies on the
